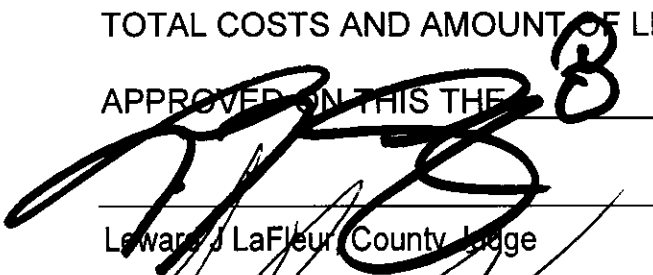
Commissioner of Precinct One, JR Ashley has estimated the cost of demolition and removal of the structure at \$6,000.00. (see estimate attached)

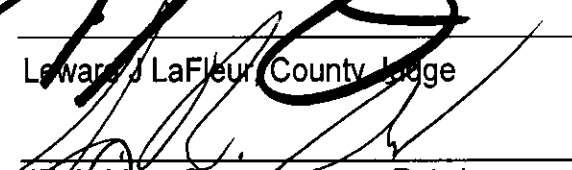

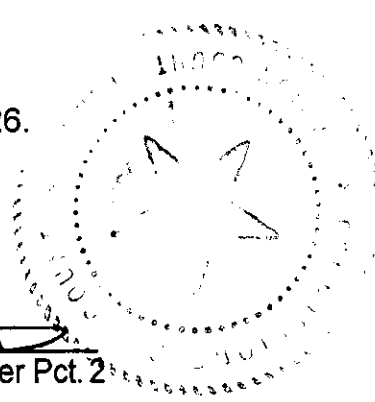
